This course is specifically designed for the retail-based mobile operator visiting domestic pool/spa sites on a regular basis.

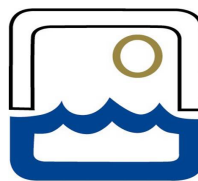
OUTCOME
